The other Terms & Conditions of their contractual engagement are as under:

- 1. The engagement of 08 Section Officer(Civil) or 02 Section Officer (Electrical) on contract basis initially for a period of 01 year which is extendable on the basis of their performance during their contract period and requirement of the corporation.
- 2.
