Note :-

1. All dependents of deceased who died while in service, medical board out and missing during the service of the BRO are free to apply on compassionate ground for the above mentioned trade wise vacancies against **vacancy year 2021**.
2. If there is no change in your financial/economic condition, number of dependents of the family, latest marital status of dependents etc as per your previous application/DD form then you have to submit a court affidavit by **15 Jun 2022** mentioning that there is no change and the application should be reconsidered for compassionate appointment for the calendar year 2021.
3. Affidavit should be signed by **first class magistrate** with his office seal. If there is change then you have to apply afresh duly filled DD form alongwith required latest documents (Copy of PPO, Income certificate, Valuation certificate of property, Affidavit of marital status of dependents etc) to reach **GRF Centre, Pune** on or before **15 Jun 2022** and **it is brought out that if any discrepancy is found in the documents at a later stage, the candidature of the applicant will be cancelled.**
4. Details of requirement of educational qualification/certificate in respect of above mentioned trades as per R&P Rule attached as **Annexure-I**.
5. The fresh DD form in case required by candidate is attached as **Annexure-II**.

1. A prescribed application form (DD form) for consideration of appointment on compassionate grounds in respect of your son is forwarded herewith. Every column may please be studied carefully and filled in properly. Main application form (DD form) needs to be signed by the candidate, a permanent Govt employee and finally by Welfare Officer (Which can be a Tehsildar, Block Development Officer or District Welfare Officer) at page 2 of the form,
2. A form of 'No Objection Certificates 'and Undertaking' by the nominee is also enclosed with the application form. Both certificates may be filled up properly. 'No Objection Certificate' needs to be signed by the NOK of the deceased while the undertaking needs to be signed by the nominee (Candidate for appointment). Both of the above certificate must be signed by a witness in token of correctness and then countersigned by Gazetted Officer with clear office seal.
3. Please forwarded photo copies of education/ technical qualification certificate and experience, if any, duly attested alongwith DD form.
4. It may please be noted that the age of your son should be between 18 to 27 years if he is 8th std passed and should between 18 to 30 years if he is matric and above. Employment action can only be taken on receipt of aforesaid application form from your son duly completed in all respect alongwith copies of educational certificates etc. In case, any discrepancy is found in furnishing the information as required in the prescribed application, it will be difficult to process the application and consequently the form will have to be returned to you for rectification. Therefore, it is important that all details are filled in properly and correctly for early processing of the case.
5. A blank certificate regarding details of family and property held etc is enclosed for completion . Please return the same after getting signature of Tehsilder / Collector alongwith the DD form.
