2. Minimum Qualifications and Experience required for post of Senior Resident will be considered in accordance with National Medical commission Notification No. NMC/MCI-23(I)/2021-MED, dated 14th February, 2022.
3. **Upper Age Limit:** 45 years.
4. **Tenure:** - The tenure for the posts of Senior Residents shall be initially for the period of One year extended maximum up to 3 years.
5. **Stipend shall be as per Government of Gujarat Norms.**

Important Note for all posts

1. Candidate should be citizen of INDIA.
2. The applicant must ensure that he/she fulfils the eligibility criteria for the post.
3. Candidate applying for more than one post need to apply separately for each post and should pay separate fees for each application.
4. All approved posts & pay scales are subject to change as may be directed by Government of Gujarat.
5. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same does not entitle him/her for being called for interview / selection.
6. Before filling / submitting the application form candidates are advised to go through the

qualifications/experience mandatory for the post and make sure that candidate possesses the same.

7. Age, Educational Qualification and Experience should be considered with reference to the last date of application to be submitted.
8. The candidate's belonging to reserved category can apply against vacancies for Unreserved / General Category and the criteria will be applicable as per unreserved category.
9. Applicant must produce original testimonials, certificates and other documents at the time of interview/ document verification time, if called. The University shall verify the antecedents and documents submitted by a candidate at any time, at the time of appointment or during the tenure of service. In case if it is detected that the documents submitted by the candidate are fake or the candidate has undesirable clandestine antecedents/background and has suppressed the said information, his/her services shall be liable to be terminated. Also, If required GUTS may ask for the payslips and income tax documents of the candidate to verify the pay scale claimed in the application.
10. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issuance of appointment letter, and/or after appointment, the University reserves the right to modify/withdraw/cancel any communication made to the candidate.
11. If any additional information is to be given, the information in separate sheet should be provided.
12. All correspondence with the candidate will be done via e-mail id as provided by the candidate in application form only.
13. The general category candidates are required to pay fee of 500/- whereas the candidates belonging to SC/ST/SEBC/EWS/PD are required to pay fee of Rs.250/-. Fees once paid shall not be refunded in any circumstances. **Fees can be paid by Demand Draft/Cheque payable at Ahmedabad drawn in favour of "Gujarat University of Transplantation Sciences, Ahmedabad"**.
14. Completely filled Application form along with payment details, photographs, self-attested copies of necessary certificates including evidence of Age, Educational Qualifications, Caste, Physical Disability, Experience and all supporting documents related to Academic Performance Indicators (if applicable), endorsement from of the current employer (if applicable), research publications etc. should be submitted through Speed post /Registered Post / Courier Services or in person to **Gujarat University of Transplantation Sciences, Opposite Trauma Centre, Civil Hospital Campus, Asarwa, Ahmedabad – 380 016**, latest by 29th July, 2022 (up to 16:00 hrs).
15. Applicants are advised to submit their application by clearly mentioning the name of applied

post on the top of sealed envelope and well in advance without waiting for the last date to avoid postal delay or any other unforeseen problems. The University will not be responsible for any postal delay at any stage.

16. Documentary proofs of age, experiences, academic qualifications and hard copies of research publications must accompany with the filled application form. If candidates fails to put copy of publication, it will be considered as candidate does not possess the same and application shall be treated as incomplete. Incomplete application form and application received after last date shall be not considered.
17. Candidates employed in Government/ Quasi Govt. /Public Sector undertaking or Local bodies or Board or Corporation or University should forward their applications (hardcopy) through proper channel. In case the applicant is in service and delay is expected in getting endorsement of the concerned employer on the original application, the applicant may submit advance copy of the application along with all the enclosures directly (without the employer's endorsement on the advance copy). If the original application through proper channel has not been received on or before last date mentioned, the applicant will have to submit a 'NO OBJECTION CERTIFICATE' from his/her employer to the University at the time of interview.
18. The Candidate appointed by direct selection shall be required to get himself registered in a State Medical Council or Dental Register or Indian Medical Council or Dental Register under the Indian Medical Council Act, 1956 or Dental Council Act,1948 at the time of his application for direct selection, if he is not so registered.
19. Fluctuations in number of posts may occur due to the resignation, promotions and other reasons even after advertisement.
