# UPPER AGE LIMIT AS ON (08th August, 2022):

 For eligibility to apply for Non-Academic Junior Resident (Dental) upper age limit as on 08<sup>th</sup> August, 2022 will be 30 years. The age relaxation for SC/ST candidates will be up to a maximum period of five (5) years & for OBC candidates up to a maximum period of three (3) years. In case of Persons with Benchmark Disability (PwBD) candidates, age relaxation will be upto a maximum period of ten (10) years for General Category, thirteen (13) years for OBC category and fifteen (15) years for SC/ST category candidates.

#### **RESERVATION FOR SC/ST/OBC/PwBD/EWS SHALL BE APPLICABLE AS PER GOVT. OF INDIA POLICY.**

#### **CRITERIA FOR PERSONS with BENCHMARK DISABILITY (PwBD) CANDIDATES**

- a) The criteria for Persons with Benchmark Disability (PwBD) will be as per Govt. of India policy.
- b) The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions & countersigned by Medical Superintendent.
- c) The constitution of the Medical Board will include consultants from related disciplines.

**Note:** All candidates, who want to get benefit of reservation/age relaxation/ exemption of fee, should enclose a copy of certificate issued by competent authority in support of their claim.

#### SELECTION PROCEDURE

- 1. Written examination may be conducted for screening depending upon the number of applications received.
- 2. List of Eligible candidates for Interview / Examination will be uploaded on website <u>www.aiimsjodhpur.edu.in</u>. Candidates are advised to check the Institute website regularly for the information related to interview / examination.
- 3. List of Selected candidates will be uploaded on website <u>www.aiimsjodhpur.edu.in</u>. Candidates are advised to check the Institute website regularly.
- Note: To be eligible for selection for these posts, the candidate should pass the qualifying examination by 31st August, 2022 & result should be declared to this effect on or before this date.

#### <u>The Candidate should bring the following original documents and one set of self-attested photocopies at the time</u> of Interview with application form:-

- i. Identity Proof (PAN Card, Passport, Driving License, Voter Card, Aadhar Card etc.)
- ii. Address Proof (Ration Card, Passport, Driving License, Aadhar Card etc.).
- iii. Certificate showing Date of Birth. (10th Certificate/Birth Certificate). *No Age relaxation will be available to SC/ST/OBC candidates applying for unreserved vacancies.*
- iv. Four recent passport size photographs.
- v. Photocopies of PAN Card and Bank Passbook (At the time of Joining for only selected candidates).
- vi. Class 10<sup>th</sup> & 12<sup>th</sup> Marksheet or Certificates.
- vii. BDS Mark sheets & Degree.
- viii. FMGE Certificate conducted by NBE (For Foreign Graduate BDS).
- ix. Attempt Certificate and Internship Completed Certificate.
- x. Registration with Dental Council of India / State Dental Council
- xi. Reservation category Certificate (OBC\*/SC/ST/PwBD) (\*Candidate should belong to non-creamy layer of Central List of OBC).
- xii. In case of OBC candidate, the OBC certificate must be issued within one year (Older certificate will not be entertained).

#### Annexure 'A' TERMS & CONDITIONS

**Tenure**: - The tenure for the posts of Junior Residents (Dental) will be as per Residency Scheme laid down by the Ministry of Health and Family Welfare, Government of India. The appointment will be **purely on contractual** basis initially for a period of 12 months. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in the institute OR for continued contractual appointment which may be renewed or terminated as decided by the Institute.

<u>**Remuneration**</u>: - The appointment will entitle the appointee to a remuneration as mentioned.

**Expiry of contract:** - The contract will automatically expire on completion of 12 months until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by the Institute. The employee can also leave the Institute by giving one month notice or one month salary in lieu thereof.

**Leave:** - The leave entitlement of the appointee shall be as per the Central Residency Scheme and Institute Policy.

The above posts are being filled-up purely on temporary basis, the candidate will have NO right to claim for permanent Employment under AIIMS or continuation of his/her services.

The Competent Authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.

The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection.

The applicants already in Government service shall have to produce Relieving Certificate from their present employer before joining the Institute. This appointment is full time and private practice of any kind is prohibited.

He/She can be posted at any other center attached with the Institute or any outreach activities of the Institute for the period to be decided by the Institute as applicable.

He/She should also note that he/she will have to conform to the rules of discipline and conduct as applicable to the Institute employees.

No travelling or other allowances will be paid to the candidate for Interview / joining the post.

The candidate should not have been convicted by any Court of Law.

Canvassing in any form will render the candidate disqualified for the post.

If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he/she will be liable to be removed from services and such action as the appointing authority may deem fit.

The decision of the Competent Authority regarding selection of the candidate will be final and no representations will be entertained in this regard. The decision of the committee shall be final and binding.
