
Following documents (self attested) needs to be submitted along with the printed application format.

- 1.) Candidates working in Government organizations must route their application through proper channel if their department rules requires so and produce NOC at the time of interview
- 2.) If the aggregate mark after final selection is equal then preference is to be given to the candidate inter senior in age as on the 1st date of the year of publication of the advertisement.
- 3.) Photo identity proof (Passport or Voter ID Card or AADHAAR Card or Pan Card)
- 4.) The age proof certificate like admit card / School leaving certificate issued by West Bengal Board of Secondary Education or similar board.
- 5.) Caste Category Certificate (if any), must be mentioned specifically in the caste certificate otherwise the candidate will be treated in "Unreserved" category.
- 6.) Self attested copy of the credentials to be sent along with the Online application Form.
