- a) The above vacancy is provisional and subject to variation. The Director, AIIMS Nagpur reserves the right to vary the vacancy as per the Govt. of India rules/circulars and requirements. **3. From other Institute:** Those who are working in Central/State Government/Semi Government/Autonomous body have to submit “No Objection Certificate” from their respective organization at the time of interview, failing which the candidature may be rejected.

**4. Age Limit:** Age limit refers to completed age in years as on last date of submission of application i.e. the date of walk-in-interview.

**5. Reservation:** As per Government of India rules.

**6. Place of Interview:** The interview will be held at venue of AIIMS, Nagpur No TA/DA will be paid for appearing in the interview.

**TERMS & CONDITIONS**

1. The appointment is purely on CONTRACT BASIS for a period of 12 months or till such time the regular appointments against these vacant posts are made, whichever is earlier, with effect from the date of joining. If the contract is not extended further, the same will lapse automatically. The appointment can also be terminated at any time, on either side, by giving one month’s notice or by paying one month’s salary without assigning any reason or failure to complete the period of three months to the satisfaction of competent authority.
2. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
3. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available/applicable to the Government Servants, appointed on regular basis.
4. The appointee shall not be granted any claim or right for regular appointment to any post of AIIMS Nagpur.
5. The appointee shall be on the whole-time appointment of the AIIMS Nagpur and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
6. The appointment to the said post will be subject to medical fitness from the competent medical board for which he/she will be sent to the designated Medical Authority.

7. Leave entitlement of the appointee shall be governed as per the existing rules of the Institute.
8. On appointment, the appointee will be required to take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed proforma.
9. The appointee is not entitled to any T.A. for attending the interview and joining the appointment.
10. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular/permanent faculty members of the AIIMS.
11. Other conditions of service will be governed by relevant rules and orders issued from time to time.
