The Institute for Plasma Research (IPR) is an Aided Institute of Department of Atomic Energy, Govt. of India devoted to research and development activities in the areas of Basic Plasma Physics, Magnetic Confinement Fusion and Industrial & Societal applications of plasmas. IPR is located in Bhat, Gandhinagar, Gujarat and also has extensions of its Laboratories at GIDC, Sector – 25, Gandhinagar, Gujarat and has a Centre at Guwahati.

## Note:

- (1) Educational/Technical Qualification should be from a recognized University/Board of Technical Education of Central or State Government.
- (2) In case Universities/Board award letter grades/CGPA/OGPA/SGPA, the same need to be indicated as equivalent percentage of marks, as per the norms adopted by that University/Board. If percentage of the marks is not indicated in application form, their candidature will not be considered.
- (3) The portal for submission of Online Application will be live from 14/10/2022.

#### **Job Description:**

The selected candidates are required to work for various activities (related to their disciplines) pertaining to research and development in the field of plasma technology and other related applications.

#### **Age Limit:**

Not exceeding 30 years. Age relaxations shall be admissible as per Central Government orders on the subject as amended from time to time.

## Pay Level:

Level 10 of Pay Matrix and Initial basic Pay ₹ 56,100/- p.m. (As per 7<sup>th</sup> CPC).

## 1. <u>SELECTION PROCEDURE:</u>

The online applications, received in response to the advertisement, shall be scrutinized on the basis of all criteria like age, educational qualification, category certificate, fee receipt etc. and only the valid applications shall be considered for screening test/interview.

In case of receipt of large number of applications, a screening test (written test) will be conducted. The test will be of two hours duration comprising objective type questions (Multiple Choice Questions) in the respective subject. Each question shall carry 3 (three) marks for correct answer and 1 (one) negative mark for incorrect answer. Marks scored in the written test will be criteria for shortlisting candidates for personal interview. Final selection will be based on the performance in the personal interview only.

#### **GENERAL INFORMATION**

- 1. Only Indian Nationals need to apply. The numbers of vacancies indicated above are provisional and may be increased or decreased depending on the actual requirement of the Institute. The persons with disabilities can also apply against the unreserved quota.
- 2. Before filling up the Online Application, the candidates must go through the detailed Advertisement. Please proceed to fill the online application only if you are satisfied that you possess the minimum Essential Qualifications stipulated for the post, otherwise submitted application(s) shall be rejected outright.
- 3. The candidates should ensure to fill correct information in their online application forms. The applicants would be called for the written test/ Interview on the basis of information filled-in by them in their online application form. In case it is found at later stage that the information furnished by applicant is false or an applicant does not fulfil any of the eligibility conditions, the candidature of such applicants would be cancelled and no correspondence in this regard would be entertained.
- 4. The date for determining the eligibility of all the candidates in every respect shall be the prescribed closing date for submission of Online Application, unless otherwise specified.
- 5. The applicants are advised to fill-in all their particulars in the Online Application carefully and upload recent passport size colour photograph and legible scan copies of the documents in support of date of

- birth, educational qualification, experience, age relaxation, etc., as submission of wrong information may lead to rejection through computer based short-listing. Institute reserves the right to reject applications not fulfilling the requisite criteria at any stage of the recruitment process.
- 6. Each applicant is advised to submit only one Online Application. However, if the candidate submits multiple Online Applications, then it must be ensured that the Online Application with the higher 'Application ID Number' is complete in all respects. Applicants who submit multiple Online Applications should note that only the Online Application with higher 'Application ID Number' i.e. latest one shall be considered for processing by the Institute.
- 7. Fee once paid shall not be refunded under any circumstances nor can be held in reserve for any other test.
- 8. Candidates seeking relaxations in age and/or payment of fee under SC/ST/OBC/PwBD/Exserviceman/EWS category are required to submit certificate in the prescribed format of Govt. Of India failing which they will be treated at par with "UNRESERVED (UR)" candidates.
- 9. All the qualifications must be from recognized Universities / Boards / Institutions only. Applicants having qualifications from other countries shall submit equivalency certificate from UGC / AIU.
- 10. Candidates working under the Govt. / Aided /Autonomous/ Quasi Govt. / Public Sector Undertakings are required to submit "NO OBJECTION CERTIFICATE" at the time of Interview, failing which they will not be allowed to appear for the Interview.
- 11. The following certificate/documents **ONLY** are acceptable as **proof of Age** (Any one):
  - i. Date of Birth as recorded in the Birth Certificate.
  - ii. Secondary School Leaving Certificate (SSLC).
  - iii. Matriculation / Secondary School Certificate in which date of birth is mentioned.
- 12. Fulfilling minimum qualification & filing online application does not entail a call for Written Test and/ or Interview. The authorities reserve all rights, not to call an applicant for Written Test and / or Interview, without assigning any reason. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the Institute shall be final.
- 13. The Institute reserves the right to reject any application without assigning any reason. Incomplete applications are liable to be summarily rejected. No interim correspondence will be entertained.
- 14. The Written Test/ Interview will be conducted in Ahmedabad / Gandhinagar. More details will be updated on website.
- 15. Second/ Sleeper class to and fro Rail/State Transport bus fare by direct and shortest route will be reimbursed to outstation candidates who are called for Interview on production and submission of original ticket/photocopy if it is a return ticket.
- 16. In addition to pay and allowances, HRA, Medical Scheme facility under its Contributory Health Service Scheme are admissible for the above post. Perquisites like New Pension Scheme, LTC, Children Education Allowance for school going children and transport facility (depending on availability of seats in the route vehicle) in lieu of Transport Allowance are admissible as per Institute's rules.
