 - c. Patient Care Assistant trainee between 11.00 am to 12.00pm at Office of General Administration, Malabar Cancer Centre.
- 2. Late comers will not be entertained.
- 3. An application fee of Rs. 100/- to be paid for all candidates.
- 4. Duration of training period will be 1 year initially and can be extended for a maximum period of 3 years, with a break on every 179 days subject to satisfactory performance (Maximum 5 tenures).
- 5. Candidates without providing copy of certificates, proving age, qualification and experience, will not be allowed for attending the Interview.
- 6. Selection will be based on qualification, experience and performance in the Interview.
- 7. Claims in respect of qualifications, experience, registration certificate etc. should be supported by copies of relevant documents;
- 8. Candidates should produce the originals at the time of Interview.
- 9. If the number of applications is high, then a written/online test will be conducted.
- 10.No TA/DA will be paid for attending the Written test/Interview
