1.13	For the post of Assistant Professor the academic score as specified in <b>Annexure-III</b> shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.  For the post of Associate Professor and Professor the academic / research score shall be calculated as specified in <b>Annexure-IV</b> . Candidates applying for the post of Associate Professor and Professor have to submit supporting documents for their claims for academic / research score as per <b>Annexure - IV</b> .
1.14	The University shall decide whether to proceed to Screening / Interview depending on the number of applications received / number of candidates shortlisted for Interview (as the case may be). 4.1	Applicants are advised to submit the application with all supporting documents in the Samarth portal well in advance without waiting till last date, to avoid any unforeseen problems. <b>The University will not be held responsible for delay at any stage.</b>
4.2	The prescribed qualification and experience are minimum and the mere fact that a candidate possesses the same will not entitle him/her for being called for interview. Vice-Chancellor's decision will be final on determining the minimum number of applications required for screening and minimum number of candidates for Interview. The University reserves the right to restrict the candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed as decided by the <u>duly constituted Screening Committee and approved by the Competent Authority based on prescribed norms of the University.</u> The Screening committee shall screen the application as per UGC/NCTE norms. The list of shortlisted and not shortlisted candidates will be displayed in the website.
