ADVERTISEMENT

Sikkim Services (Combined Recruitment) Examination, 2022

Online applications are invited from eligible local candidates for filling up various posts in the Junior Grade of various State Services under Government of Sikkim as detailed in Appendix-II of The Sikkim Services (Combined Recruitment) Examination Rules, 2022 (notified vide notification bearing no. 104/GEN/DOP dated 23.09.2022) on temporary-regular basis through Direct Recruitment. All applications are to be made online at the Commission's website www.spsc.sikkim.gov.in

However, during the period of Probation/Apprenticeship/Training, pay shall be governed by Notification No. 489/GEN/DOP dated 31.10.2011.

The Distribution of Vacancies, Eligibility Conditions (Minimum Educational Qualification) and the Age Limit for various services is detailed hereunder.

Should be a Graduate Degree holder in any field from a recognised University

(B) Age Limit:

Should have attained the age of 21 years, but should not have exceeded 40 years as on 01/10/2022, in terms of Notification No: M(3)/(55)/GEN/DOP/PT.-III dated: 03/07/2017.

(II) **ELIGIBILITY CONDITIONS:**

(A) **Minimum Educational Qualification:**

Should be a Graduate Degree holder in any field from a recognised University

(B) **Age Limit:**

Should have attained the age of 21 years, but should not have exceeded 32 years as on 01/10/2022, in terms of Notification No: 103/GEN/DOP dated: 22/09/2022.

Note 4: Age relaxation provided to Ex-Servicemen in terms of Notification No. 157/Gen/Est dated 20.08.1988 shall NOT be applicable in the case of recruitment to the post of Deputy Superintendent of Police under the Sikkim State Police Service.

(C) **Physical Requirements:**

Candidates desirous of applying for the post of Deputy Superintendent of Police would be required to fulfil the following Minimum Physical Measurements. Further, they would also be required to successfully complete all of the five tests in order to qualify the Physical Endurance Test (PET).

The parameters for the Minimum Physical Measurements and the details of the tests to be conducted as part of the Physical Endurance Test (PET) is detailed in the table below.

The following physical requirements are only applicable to the candidates applying for the post of Deputy Superintendent of Police under the Sikkim State Police Service.

(II) **ELIGIBILITY CONDITIONS:**

2. **Should have undergone a Computer Course of minimum 03 (three) months duration from a recognised institute.**

Note 8: The candidate should have completed the Computer Course before the date of publication of this advertisement.

Note 9: Candidates who have studied computer science or other allied subjects in Class X or Class XII or Graduation or Higher Degree Courses, for a duration not less than 3 months, can submit the marksheet of the same in lieu of the Computer Course Certificate.

(B) **Age Limit:**

Should have attained the age of 21 years, but should not have exceeded 40 years as on 01A0/2022, in terms of Notification No: M(3)/(55)/GEN/DOP/PT.-III dated: 03/07/2017.

Other Miscellaneous instructions relating to the Sikkim Service (Combined Recruitment) Examination, 2022 are detailed hereunder.

(5) **OTHER QUALIFICATIONS:**

(a)	Should have knowledge of any of the State Languages.
(b)	Should be conversant with customs and usages of Sikkim.

(6) **REQUIRED DOCUMENTS:**

(a)	Candidate must be in possession of either Sikkim Subject Certificate or Certificate of Identification issued by the competent authority under relevant orders of the State Government.
(b)	Should have Valid Local Employment Card issued by the appropriate authority of the Government of Sikkim.
(c)	No Objection Certificate from the Head of Department in case of employed candidate.
(d)	Marital Status certificate (for female candidates). In case of a married female candidate, COI/SSC of Husband should be provided.

- (7) **PLAN AND SCHEME & SYLLABUS OF EXAMINATION:** The Sikkim Services (Combined Recruitment) Examination, 2022 will be conducted in terms of the rules notified under The Sikkim Services (Combined Recruitment) Examination Rules, 2022. The same can be downloaded from the Sikkim Public Service Commission website. Candidates are advised to refer to **APPENDIX - I** and **APPENDIX-III** of **The Sikkim Services (Combined Recruitment) Examination Rules, 2022** for detailed Plan and Scheme & Syllabus for the Examination respectively.
- (8) Candidate should go through the advertisement and read the instructions provided on the website carefully before applying online. Applications received through any other mode shall not be accepted and shall be summarily rejected.
- (9) The candidates are advised to apply online from our website <http://spsc.sikkim.gov.in/> on or before the stipulated date and time. Application submitted thereafter will not be accepted and SPSC shall not be responsible for the same.
- (10) Rejection list of candidates who do not qualify for the post as per the advertised criteria will be uploaded in the SPSC website on the stipulated date and if any of the rejected candidates have reservation on rejection of application, they should submit their grievances along with justification to the office of the Controller, SPSC within the stipulated period.
- (11) Application fee amounting to Rs 500/- only per advertised post may be paid online through Net Banking or Credit or Debit card. The amount once deposited shall not be refunded or adjusted against any other purpose.
- (12) e-Admit Cards can be downloaded and printed by the eligible candidates after a Notice for the same shall be published by the Commission in the official website of the Commission.
- (13) Candidates are directed to bring a Photo Identity proof (such as Aadhaar Card, Voter ID Card, Driving License) along with valid e-Admit cards to the examination centre for proof of identity.
- (14) Those candidates who qualify in the Main (Written) Examination will be called for the scrutiny of documents and viva-voce. Short listed candidates are required to submit attested Photocopies of all relevant documents on the dates specified by the Commission.

- (15) No TA/DA is admissible for attending the written examination / viva-voce.
- (16) Admission to all the stages of examination for which candidates are admitted by the Commission viz. Written (Preliminary) Examination, Physical Endurance Test (PET), Written (Main) Examination and the Personality Test - Interview shall be purely provisional and subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfil any of the eligibility conditions, their candidature for the post shall be cancelled by the Commission without notice.
- (17) The Commission shall entertain application on review or RTI/Correspondence only after the entire process of recruitment is complete.
- (18) Any further instructions/corrigendum/addendum shall be uploaded only on Sikkim Public Service Commission website.
