- A minimum of ten years of teaching and/or research and/or extension experience in the University as Assistant Professor-cum-Jr. Scientist/Associate Professor-cum-Senior Scientist/ Professor-cum-Chief Scientist, and/or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate or 05 post-graduate students.


Note: Academic / Research / Extension Score obtained as per **Annexure** to this Notification by a short-listed candidate called for the interview shall have a weightage of 80/100 marks (80%) and 20/100 marks (20%) shall be for interview before the prescribed Selection Committee.

The candidate's ability for teaching, research and extension appditude shall be assessed through a seminar/lecture in a classroom situation or discussion during the interview.
