PUBLIC NOTICE

RECRUITMENT TO 159 POSTS OF CIVIL JUDGES (JUNIOR DIVISION-CUM JUDICIAL MAGISTRATES) IN THE STATE OF PUNJAB.

1. It is for the information of the candidates who had qualified the preliminary examination for the ibid posts that as per the result declared by Hon'ble Punjab and Haryana High Court on 22/02/2023, the list of candidates to be admitted for the Main Written Examination has been uploaded on the website of the Commission as **Annexure-Z**, this list is subject to outcome of CWP No. 22898 of 2022 titled as "*Sherya Bublani v/s State of Punjab*" and CWP No. 23247 of 2022 titled as "*Sandeep Kaur v/s State of Punjab*".
2. The Scrutiny of documents will be done after the declaration of Main Written Examination result. The candidates applying for the Main Written Examination should ensure that they fulfill all the eligibility conditions for admission to the examination. The admission for examination is purely provisional subject to satisfying the prescribed eligibility.
3. It is for information of the all concerned that the PCS (JB) Main Written Examination shall be conducted from 02.06.2023 to 04.06.2023 (tentatively) at Chandigarh. It is further informed to the candidates (eligible provisionally) that they are again required to Register Online for the Main Examination for which the link is available on the website of the Commission. **The Online Registration link for this purpose will be available from 10/04/2023 to 24/04/2023.** The candidates are required only to register online for the Mains examination and are **not required to send any other document or application form separately to the Commission.** The candidates failing to register online for the Main examination within the prescribed time limit would not be able to get their admit cards for the Main examination.
4. The eligible candidates of Person with benchmark disabilities shall have to apply separately to PPSC for scribe or extra time (compensatory time) along with supporting documents (i.e. medical disability certificate, request for compensatory time, request for scribe and compensatory time along with relevant annexure) by 22/05/2023 till 5 PM by hand in the office of PPSC or via email pwdjudicial2022@gmail.com.
5. The number of qualified candidates to be called for viva-voce in order of the marks obtained in the written examination shall not exceed three times the number of vacancies advertised. However, if the last qualified candidate to be called for interview is bracketed with the candidates exceeding three times by obtaining equal marks, than all of the bracketed candidates shall be called for interview in spite of the fact that the number of candidates to be called for interview exceeds three times.
