1. **Name of Post** : **Jr. Grade of MES, P&E Cadre (Electrical Wing)**
2. **Name of Department** : **Power & Electricity**
3. **Classification** : **Group 'A' (Gazetted) (Non-Ministerial)**
4. **No. of Posts** : **(a) Electrical Engineer – 3 (Three)**
(b) Mechanical Engineer – 1 (One)
(c) Computer Engineer – 1 (One)
5. **Pay** : **Level 10 in the Pay Matrix (Rs.56,100 – Rs.1,24,500)**
6. **Eligibility Conditions** :

- i) **Nationality:** A candidate must be a citizen of India as defined in Article 5 to 8 of the Constitution of India.
- ii) **Age limit:** A candidate must not be less than 21 years and not be more than 35 years of age on the first day of the month of recruitment. The upper age limit is relaxable by 5 years in case of candidates belonging to Scheduled Caste/Scheduled Tribe and other backward classes as laid down by the Government and as notified by the Government vide No. A.12011/1/2019-P&AR (GSW) dt.03.06.2019.

Note: A candidate should note that the date of birth as recorded in the HSLC/HSSLC examination certificate or an equivalent certificate on the date of submission of application will be accepted by the Commission and no subsequent request for its change will be considered or granted.

Provided that for advertisement made during calendar years of 2023 and 2024, the candidate must not have exceeded the age of 37 years on 1st August of the particular calendar year.

iii) **Educational Qualifications:**

- a) Graduate Electrical / Mechanical / Computer Engineer or equivalent degree from a University incorporated by an Act of the Central or State Legislature in India or other Educational Institutions established by an Act of Parliament or declared to be deemed as Universities under Section 3 of the University Grants Commission Act, 1956;
OR Passed Section A and B of Examinations of the Institution of Engineers (India);
OR Obtained a degree in Electrical / Mechanical / Computer Engineering from such foreign University/ College/ Institution and under such conditions as may be recognised by the Government for the purpose from time to time,
OR Passed Graduate Membership Examination of the Institute of Electronics and Telecommunication Engineers (India)
- b) Knowledge of Mizo Language upto Middle School Standard.

Note: A candidate who has appeared at an examination, the passing of which would render them educationally qualified for the examination, but has not been informed of the result or have not been declared at the time of submission of the application, may be eligible for admission to the examination. All such candidates included in the list prepared by the Commission shall be required to produce proof of passing the requisite examination at the time of interview before the selection board/committee, failing which such candidates will not be appointed to the service.

7. Disqualification :

- i) Canvassing by a candidate directly or indirectly will disqualify the candidate.
- ii) Any candidate who, on verification at any stage of the recruitment process, does not fulfil any of the eligibility conditions, will be disqualified.

Government servants will have to apply through proper channel.
