



## Notification for Apprenticeship Training

(Advt No Apprenticeship/2023-24/HR-01)

Applications through online are invited from the ITI passed candidates in the trade mentioned herein below for one year Apprentice Training under Apprentice Act, 1961 at NHPC Regional Office, Jammu a Unit of NHPC Limited (A Govt. of India Enterprise) for the session 2023-24:

1. Candidates having domicile of UT of Jammu & Kashmir only need to apply
2. **Age:** The age of the candidate should be between 18 to 30 years as on 30.12.2023. A relaxation in upper age is admissible as per the Govt of India guidelines for SC/ST/OBC/PH candidates.
3. **Stipend:** Monthly Stipend will be as per Apprenticeship Act, 1961 and NAPS or as amended from time to time. The Apprentice will not be eligible for any other allowances or benefits.
4. **Reservation:**  
Govt Guidelines under Apprenticeship Act on Reservation for SC/ST/OBC/EWS/PwBD will be followed. Applicants who are claiming reservation under above categories shall provide certificate as per Government standard format issued by the Competent Authority, failing which their claim for reservation will be considered as 'General' category only.
5. **Duration of Training:** The duration of the apprenticeship training will be one year. The apprenticeship contract will have to be executed by the selected

candidate in this regard. The contract would be terminated automatically after completion of the apprenticeship training period. Shortlisted candidates have to furnish undertaking that after completion of training they cannot demand employment.

#### 6. Preference will be given as under:-

Candidates who meet all above basic criteria will be given preference as under:

- a) Project Affected Families of NHPC projects/ power stations located in UT of J&K will be given first preference
  - b) Candidates from Jammu District will be given Second preference.
  - c) Candidates of other District of UT of J&K will be given third preference.
7. The above notified vacancies may increase or decrease as per the requirement of office.
8. Candidates should be eligible with respect to age criteria and education qualification as on **30.12.2023**. Result awaited candidates need not to apply.
9. **Employment in NHPC:** Candidates selected for one year apprenticeship training shall have no claim whatsoever as to any extension of training and direct or indirect employment in NHPC Limited.
10. No boarding/lodging and transport shall be provided to any candidate by NHPC Ltd. Candidates should make their own arrangements during the training period.
