3. The Interview will be held on 18 December 2023. If the number of candidates is more than 30 a written examination will be held followed by the interview of shortlisted candidates based on marks.
4. The result will be declared and displayed on the website/Notice board in VMMC & SJH.
5. Candidates have to submit the duly self-attested documents. Selected candidates have to bring all the original documents mentioned above in the original for verification at the time of joining.

Terms and Conditions:

1. The above position is on a temporary contract basis.
2. The Appointing Authority has the right to accept/reject any application without assigning any reason (s) and no correspondence in this matter will be entertained.
3. The appointment can be terminated with one month's notice from either side without assigning any reason.
